## 1:30 PM - ANNUAL GENERAL MEETING

Opening prayer by Irene Otter, an Eeyou Elder from the Waswanipi community

#### 1. OPENING OF THE MEETING

Dave Laveau, Executive Director, welcomed all participants attending both in-person and virtually, and expressed gratitude to the Oujé-Bougoumou community for their hospitality throughout the week.

ITQ acknowledged that the meeting was taking place on land steeped in thousands of years of history. The Eeyou Nation is the steward of the lands and waters of the territory where participants were gathered.

The Indigenous languages, cultures, and identities that continue to enrich this unceded territory were also acknowledged. The ongoing presence of several Indigenous Nations was recognized, along with the importance of their contributions—past, present, and future.

A video address by Geneviève Cantin, President and CEO of the Alliance de l'industrie touristique du Québec, was presented.

Dave Laveau proceeded to introduce the President.

## 4. PRESENTATION OF FINANCIAL STATEMENTS AUDITED ON MARCH 31, 2024

Presentation by Myriam Lacroix, Auditor at Raymond Chabot Grant Thornton. Patricia Auclair, Deputy Executive Director, addressed questions and comments as necessary.

The financial statements, previously presented and approved by Treasurer Michelle Picard and the board members at the June 27 board meeting, were shared with members present.

#### 5. APPPOINTMENT OF THE AUDITOR FOR 2024-2025

The board of directors recommended continuing with RCGT based on the duly submitted 2024-2026 service proposal.

It was thereby resolved to appoint RCGT as auditor for 2024-2025.

#### 6. 2023-2024 ANNUAL REPORT

The ITQ team presented the organization's annual report.

Dave Laveau began by stating that the annual report was available in both official languages on the website, as well as on the online platform for participants attending the AGM remotely. Printed copies were available upon request. The team took turns presenting the key initiatives undertaken in 2023–2024.

#### 7. ELECTIONS

Steeve asked the assembly to appoint a president and a secretary for the elections and proposed Dave and Patricia for these roles.

Patricia Auclair was appointed as president, and Marc Plourde as secretary for the elections.

Patricia Auclair outlined ITQ's election procedures. Each candidate would be allotted time to introduce themselves and present their aspirations as a potential board member, whether in-person, virtually, or via a pre-recorded video. Examples: government, band council, development agencies, economic development entities, Indigenous organizations, etc.

# **ASSOCIATE MEMBER: 1 seat up for election**

Associate members support ITQ's mission and objectives. These are non-Indigenous businesses or organizations. They are interested in ITQ's objectives and initiatives and are involved in active members' activities.

Examples: service providers, collaborators, sectoral tourism associations, regional tourism associations, etc.

# **ACTIVE MEMBER: 2 seats up for election**

Active members actively participate in fulfilling ITQ's mission and objectives. They must oversee a majority Indigenous-owned and operated tourism business or corporation.

Examples: entrepreneurs, festivals, inns, museums, shops, etc.

Active members are divided into five sub-categories (regular, outfitters, event, artists/artisans, and auxiliary).

**Auxiliary members**, an active member sub-category, actively contribute to fulfilling ITQ's mission and objectives. They must oversee an Indigenous-owned and operated tourism business or corporation. The business must have been established within the last two years. **Auxiliary members do not have voting rights and cannot sit on the board of directors.**
